

C/1434 Pradip Majhi, C/1514 Anupam Sarkar, C/1326 Paresht Paul all of Barasat PS accompany SDPO, Barasat, Barasat PD along with RAI & I/C Madhyamgram PS along with officers SI Dipankar Ghosh, SI Himadri Dogra, SI Prasent Halder and force of Madhyamgram PS arrived at the spot. Then SDPO, Barasat, Barasat PD & all officers and force tried to control this situation, chased them and the unruly mob tried to flee away from the spot, but somehow we managed to apprehend the above noted persons but other 15/20 persons fled away from the spot.

I rescued two injured person one male namely Khalid Sik. (36) S/O Sik. Mokkel of Raghunathganj, Talal Bardanga, P.S - Kultala, Dist. Murshidabad A/P Abdalpur near Pragati Sangha, P.O - Badu, P.S - Madhyamgram and one female namely Neherabanu Bibi (32) D/O Ansar Ali of Prabhakarkati, P.O - Padmalaypur, P.S - Amdanga from the spot who received grievous bleeding injuries on their persons and shifted to Barasat Govt. Medical College & Hospital where they are admitted now in serious conditions. On interrogation the above noted accused persons confessed their guilt and I arrested them after maintaining all legal formalities of laws and taken them into my custody on 19.06.2024 in between 12:35 hrs and 13:05 hrs. During search I recovered and seized (i) Some broken glasses of vehicle window of Govt. police vehicle bearing Reg. no. WB 25B 2997, (ii) One brick which was used to break the window of police vehicle, (iii) Some brickbats and stones, (iv) 04 pcs of wooden sticks from the spot after preparing proper seizure list on 19.06.2024 in between 13:25 hrs and 13:55 hrs. During incident I along with force C/752 Asish Mondal, LC/357 Nilima Sarkar and driver CV/123 Amit Chakraborty of Barasat PS received injuries seriously and treated medically at Barasat Govt. Medical College & Hospital on 19.06.2024. The Govt. vehicle bearing Reg. no. WB 25B 2997 has been damaged. I found and identified the persons namely (1) Dilla @ Dilip Dey, owner of Matri builders at Satyanarayan pally near Kamakkha Mandir, (2) Babai @ Borka, cable business at Madhumurali near pond, (3) Babai @ Dinabandhu Saha of near Yubagosthi Club, Barasat, (4) Reni of near Yubagosthi Club, Barasat (5) Raja S/O Pran of Madhumurali, (6) Amit Biswas C/O his Grandfather Binay Biswas of Nadibhag, Kadamtala near Jyoti Sweets, (7) Hasan Ali S/O Abdul Rohit of Nadibhag Mollapara, P.S - Barasat, (8) Milan Dey @ Nani of Madhumurali Pukurpur, P.S - Barasat, (9) Subham Majumder @ Babai of Madhumurali behind Madhumurali Swastha Kendra, P.S - Barasat and 10/15 others who managed to escape themselves from the spot.

They committed offence of confiding and assaulting to commit murder two persons and prevention of discharging govt. duty and attacked and assaulted to police personnel, damaged the public properties.

Therefore, I pray that a case under section 341/323/325/354/307/186/188/332/333/353/506/509/34 IPC & 3 PDPP Act may kindly be started against the above noted 10 arrested accused persons and 09 absconding accused persons and 10/15 others and arrange for its investigation.

WB 25B 2997 driven by CV/123 Amit Chakraborty vide Barasat PS GDE No. 1467 Dt. 19.06.2024 & CC No. 2505/24 Dt. 19.06.2024. During my morning RT mobile duty at about 11:35 hrs received information from duty officer ASI Dilip Roy of Barasat PS that a mob confined two persons one male & one female at nearby Central Modern School, Ghola Kachari Road under PS Barasat suspecting them as child kidnapper and they are assaulting them vide Barasat PS GDE No. 1489 Dt. 19.06.2024. Receiving this information suddenly I along with force arrived at the spot and found that the above noted with some others including ladies are assaulting to one male & one female person with wooden stick, bamboo sticks, brick etc mercilessly. We tried to rescue the male and female person from there clutches, but they did not hear my command and they also attacked & assaulted us with wooden stick, bamboo sticks etc and damaged our Govt. vehicle by brick. I informed the matter to I/C Barasat PS and requested him to send more officer & force to control the situation. Then, SI Ramkrishna Guria, SI Ashim Kumar Das, SI Malay Mondal, SI Animesh Ghosh, SI Bholanath Roy, ASI Jagadish Sardar, ASI Supriyo Bhadra along with force
